## 1. Introduction

This Cookie Policy explains how BestWing Global ("we", "us", or "BWG") uses cookies and similar technologies to operate our website <https://bestwingglobal.com>, enhance performance, and provide a more personalised trading experience.

Cookies help us remember user preferences, improve website functionality, analyse traffic, and deliver relevant advertising, always in compliance with applicable privacy and data protection laws, including the EU ePrivacy Directive, GDPR, CCPA/CPRA, and the Australian Privacy Principles (APPs).

## 2. What Are Cookies

Cookies are small text files that are placed on your device when you visit a website. They allow us to recognise your device, store certain information, and support the website's functionality.

Cookies may be set directly by us ("first-party cookies") or by third-party services ("third-party cookies") we use for analytics, advertising, or functionality.

## 3. Types of Cookies We Use

**BWG uses four main categories of cookies:**

### **Strictly Necessary Cookies**

These cookies are essential for website functionality, such as account login, session management, and security. They cannot be disabled through our cookie settings panel.

### **Performance and Analytics Cookies**

These cookies help us understand how visitors interact with our site by collecting aggregated data on page visits, load times, and navigation patterns. This information is used to optimize performance and usability.

### **Functional Cookies**

Functional cookies store user preferences such as language, region, and display settings. They enhance the user experience by remembering previous choices.

### **Advertising and Targeting Cookies**

These cookies track user behaviour across websites to deliver relevant advertisements and measure the effectiveness of campaigns. Some of these cookies are set by third-party advertising networks with which we work.

#### 4. Detailed Cookie Table

The following table lists representative examples of cookies used on our website. Specific cookie names may vary by region or platform version.

- Consent preferences are securely stored for **6 months**.
- You can withdraw or change your consent at any time by using our cookie settings interface or adjusting browser preferences.

If you reject cookies, some website features may not function as intended.

#### 6. Third-Party Cookies

Certain cookies are set by trusted partners and service providers, including analytics platforms and advertising networks.

These partners may process data in accordance with their own privacy and cookie policies. You can review their specific terms by visiting the cookie settings menu or their official policy pages.

## 7. Managing Cookies

You can control cookies through several methods:

- **Cookie Banner:** Modify consent directly on our website.
- **Browser Settings:** Block or delete cookies through your browser's privacy tools.
- **Do Not Track:** Enable this option to limit third-party tracking.
- **Ad Preferences:** Opt out of personalised advertising through your Google or Meta ad settings.

Please note that deleting or blocking cookies may impact the functionality or user experience of certain site features.

## 8. Data Retention for Cookie Consent

BWG maintains consent logs for **6 months** to demonstrate compliance with applicable data protection laws. After this period, records are securely deleted or anonymized.
